#### Potential Threats to Refugee Resettlement & Refugee Rights

- Shutting down or temporarily pausing resettlement program
- Drastically reducing numbers of resettled refugees
- Not resettling refugees due to their religion, country of origin
- Burdensome requirements to hinder program
- Allowing communities to "veto" resettling refugees
- Cutting funding
- Mandating registration for refugees, Muslims
- Anti-refugee bills in U.S. Congress, state legislature, localities
- Hate crimes, abuse, discrimination, increased fear





### Potential Threats to Immigrants' Rights

- Drastically increase deportations and raids in homes and places of employment
- Stop the Deferred Action for Childhood Arrivals (DACA) program
- Stop processing visas for certain individuals based on religion or nationality
- Force local police to serve as immigration enforcement officers
- Militarize U.S. borders, resulting in more deaths in the desert and more human rights abuses by border patrol officials
- Deny life-saving protection to refugees fleeing Central America and turn them back to situations of exploitation and violence





#### What can we do?

- Immediately make your voices heard to your local, state and national elected leaders: I SUPPORT REFUGEE RESETTLEMENT 1-866-940-2439 & www.usa.gov/elected-officials
- Communicate that you will stand with immigrants and refugees through upcoming challenges
- Create spaces of healing and strategizing
- Educate communities about their rights

- Reach out to local, state and national policy makers NOW to let them know that refugee resettlement is a priority for you and your community, and that you're looking to them to defend it against attacks. Ask them to declare that your community is a welcoming community.





#### Organizing to Protect Immigrant & Refugee Rights

- Come together and build a team with refugees, volunteers, staff, faith groups, other organizations, allies, etc. to strategize
  - Reach out to conservative groups and individuals who can demonstrate support for resettlement and urge policy makers on all levels to defend the program against attacks
  - Prepare your network to take prophetic actions, including civil disobedience, by reflecting on the need and strategic use of civil disobedience.

## Sanctuary as part of our faith tradition

 As the faith community, we are called to accompany our community members, congregants and neighbors facing deportation.





## Sanctuary Movement 2014-2016

Since the 1980's, the Sanctuary Movement has taken up the call to welcome the stranger by providing safe haven to immigrants and refugees in need. Since 2014, 13 churches in 9 cities have provided Sanctuary to 15 individuals seeking to remain in their communities. This new campaign has mobilized 400 congregations to stop deportations calls on all congregations to open their doors and provide refuge for immigrants who are singled out for deportation. Congregations also welcome anyone who has been victimized by discrimination or hate crimes into these sacred safe spaces to bring the community together around love, respect and dignity for all.

#### Shift in Strategy

- Open congregations doors to vulnerable communities being targeted by administration
- Work to protect Prosecutorial Discretion and Sensitive Locations so that we can still win cases- this remains a question about next administration.
- Defend DACA, push back against border wall or mandatory minimums for unlawful reentry
- Working with evangelicals on outreach to the administration





#### **Expanding Sanctuary**

- Faith communities are also supporting those willing to answer the call to provide sanctuary at schools, hospitals, college campuses, community centers and family homes. At this press conference faith leaders commit to work with partner immigrants rights organizations to create sacred space of sanctuary wherever it is needed.
- Working with partners like Cosecha Movement, Showing Up for Racial Justice and PICO





### KYR & Protection Network Model

- The purpose of a Protection Network is a mutual aid support network whose members unite to support one another to have a family and community plan of action in case of a raid, detention and/or deportation.
  - Power of Attorney Forms/Action Plan
  - Trainings
  - Pro-bono legal support
  - Rapid Response System
  - <u>Visitations & Letter-writing</u>
  - Defense Fund
  - Advocacy & Community Organizing





#### Legal Questions


- Everyone always wants to know are we breaking the law?


