## **Northwest Association Annual Meeting Held**

*Reconnecting and Looking Ahead* shaped the theme of the 62<sup>nd</sup> Annual Meeting of the Northwest Wisconsin Association of the United Church of Christ. 74 delegates and clergy (60 in person and 14 by Zoom) took part in the gathering, which was held at First Congregational UCC in Eau Claire on April 20.

The Reverend Dr. Stephanie Perdew, Director of the Damascus Project of the Wisconsin and Minnesota Conferences, offered the Keynote speech. A good look at quality data, she suggested, leads her to believe that gloom and doom projections for UCC congregations are not necessarily true. She offered statistics which indicate that decline in the two conferences in which she works has slowed since the COVID-19 pandemic, and not accelerated. Patterns have changed in church attendance; many who attended every Sunday now go to two or three Sunday services a month. Most of the people who affiliated with a church but rarely attended worship still give generously. A five percent increase in new members would halt the declines of recent years. A church of sixty members needs to gain only three new people to halt its membership decline.

Yet the struggles for local congregations to look outside their walls for mission (and the

conflicts that come with such change) remain with us.

Dr. Perdue offered stories from the Lincoln, Nebraska UCC congregations where she grew up. One congregation managed to find new ministry in a changing city after a nearby factory closed by finding new ministry with the Latino people who came to work in meatpacking plants. Another, which had changed locations to get closer to suburban neighborhoods, had three different pastors in a few years as they grieved the loss of their old building. Only now, after some help from their conference's staff, are they finding a new direction.

Association Secretary Rev. David Huber reported that the Association's finances are in good condition. Delegates approved a budget of \$36,300 for 2025, and Association dues remain at \$4.50 per member.

Rev. Kathleen Remund completed her term as the Association Moderator, and Steve Ottman, a layperson from St. Paul's UCC in Ellsworth, will take her place and serve in that role through the 2026 Annual meeting.

The Hancock United Church of Christ was welcomed into membership in the Northwest Association, moving its connection to the UCC from the Northeast Wisconsin Association.

## Minnesota Conference Offers Interim Ministry Training

The Minnesota Conference of the United Church of Christ has teamed up with the Interim Ministry Network to offer a course in *Effective Transitional Leadership Training*.

The course will begin with a three-day training session on June 10, 11, and 12 at the Minnesota Conference's office, located at 122 West Franklin Avenue in Minneapolis. The following 12 months of instruction will take place virtually as a cohort group with a facilitator.

The cost is \$200, and organizers have announced that the normal Damascus Project discount code for Wisconsin and Minnesota Conference members is not available for this session.

The Reverend Chris Hart, an authorized minister of the United Church of Christ and an Interim Ministry Network Trainer, will lead the session.

## Northwest Association Pulpit Supply List May 2024

Churches should be fair and forthright in agreeing upon honorarium and travel expenses for persons they invite to provide pulpit supply. The WI Conference Division of Church and Ministry suggests a minimum of \$150 plus mileage reimbursed at the IRS rate for **2024**, **67 cents per mile**. *Note: 2024 minimum* \$175.

Where a church has two points and two services, consider an additional \$75 plus mileage.

Conference staff persons serve local congregations in a variety of ways. Honoraria are not accepted, and travel costs are covered by the Conference travel budget. Except in emergencies, Conference staff cannot provide pulpit supply; however, the staff welcomes opportunities to preach for special occasions or to meet with members of the congregation.

<u>Please note</u>: Persons licensed to the NW Association and ordained pastors are authorized to administer the Sacraments.
